The Standard Letter of Agency Document

A Letter of Agency (LOA) must be completed by the end-user and supplied to MCEC Fiber, Inc. upon request. The LOA must contain the name and current service address of the end-user and the numbers that will be ported to MCEC Fiber, Inc. the end-user's current carrier. The LOA used must comply with FCC regulations and must be dated and signed by the end-user or a person who has the authority to act as a legal agent.
